I am writing this letter in regards to a trial you presided over for Chad Evans. I would like start by thanking you for your time not only given to Chad's trial...but also to my letter now.

Since Friday, December 21st a day has not gone by that I don't replay the verdict given by the Jury over and over. I can't help to think what a sad day that was not only for Chad and his family, but for us, his friends, as well. I am compelled on this 4th day of February, which would have been Cassidy's third birthday, to share with you the other side of Chad Evans which you never heard about during his two week of trial.

Chad is one of the most wonderful friends I have been blessed to know. He is kind hearted, friendly and always willing to lend a helping hand. As with everyone...there are times in our lives we are faced with obstacles and without the support of family and friends it would be much more difficult to overcome these troublesome times. If it were not for Chad's love and support I know I would have been at a loss on many occasions. I remember one time in particular when I had just ended a long relationship; Chad called me everyday...sometimes three and four times just to see how I was doing. He would stop by just to give me a hug and tell me things would be all right. His friendship and kind words were a strength to me then as they still are today. I remember Chad offering to help me move...offering to let me stay with him for awhile to get on my feet...offering me money if I needed it.

On another occasion I was telling Chad about a project I was working on, A Children's Christmas. I was planning a party for 250 underprivileged children from the Rochester-Dover area. I was explaining some of the events we were to hold and Chad immediately piped in, "Let me talk to some of the people at McDonalds....I'll see if we can donate Happy Meals to all the children and their families." Not only did they donate Happy Meals to everyone...but when Chad found out we were short handed for volunteers he made sure he was there with a few other people to help us get the food to the hall, distribute it to everyone and get things cleaned up. He worked on this project every year with me up until this past year. Even though Chad was fighting for his freedom...he still told me to contact McDonalds for the Happy Meals and if anyone had any questions he would talk to them. This is only one of the many times Chad has helped me. Whenever I needed a hand or someone to bounce ideas off of....he was there for me in an instant. That is just the kind of person Chad is, always looking to help everyone else.

One of the cutest things I remember Chad doing was when he was getting ready for the Grand Opening of the Rochester McDonald's Playplace. He called and invited all the children from St. Charles Children's Home (A local foster home for children who have been removed from their home for one reason or another) to be the first ones to play in the new Playplace. Chad was so excited to do a nice gesture for the children...he went to a silkscreening company and had t-shirts made for the children from St. Charles Children's Home that said, "I'm Special" or something like that with a picture of the PlayPlace on them. Chad paid for that out of his own pocket because it was that little something extra that would make the children feel great! This is just one of many examples of how much Chad loves and cares for children.

I guess that is why I am writing you this letter. To explain to you that although I believe the Jury did their best to be fair and make a decision based on the information they were presented with, I feel something went terribly wrong. If you could see Chad with his son, could have seen him with Cassidy, or with any child you would see the kind of man he is. If I had children, I would trust him with their lives. I trust him with mine.

Chad's house is off a fairly busy road. One night he heard a loud crash outside of his home and he immediately ran to the door to see what happened. When he saw the two cars crumpled in front of his lawn he asked Tristan to call 911 and keep the children inside. He told her there was fire around one of the cars. As Chad ran to the cars he could smell gas and was nervous of how close the gas leak was to the actual flames. I don't remember exactly how many people were in the cars. I believe there were 3 or 4 people in the car that actually caused the accident and 2 in the other car. Chad had pulled all but 1 person from the vehicles. This gentleman's leg was lodged under the front seat. Chad told me he felt bad for the pain this poor guy was in because every time Chad tried to pull him, the man would moan. Chad was doing his best to get him out of the car. He could hear popping and snapping sounds from the fire that was now getting closer to him since Chad could feel the warmth from the flames on his arms and back. Finally, as the people were yelling to Chad from his lawn, Chad told the man he would count to 3 and then would pull the man hard to free him from the car. One the count of 3 Chad pulled as hard as he could and they both fell to the ground. A few of the others came to help Chad pull the man away from the cars and within seconds of doing so the fire and engulfed the vehicle and there were some small explosions as the fire hit the gas and oil. All the people involved in the accident lived and I attribute that to Chad's bravery, his compassion, and quick thinking. I think this is a perfect example of who the real Chad Evans is. He risked his life for perfect strangers. He received an award from the City of Rochester as well as the Governor of NH and other little ones I believe. Local newspapers covered this story about a local hero. Chad is a hero not a murderer.

On one occasion probably 5 years ago Chad had to give a speech to a bunch of Managers in Training. He asked me to help him out with what he was going to talk about. Without realizing what I was getting myself into, I readily agreed to help him. Well, to my surprise Chad had a Wonder Woman costume on my desk the day before his lecture. I almost died laughing. He wanted me to wear it...he was going to be dressed as Superman. I thought this was so funny...what could he be possibly saying to these people to make wearing these costumes tie into it. I soon found out. The next day Chad walked into the room in his outfit....the crowd started to roar with laughter. Chad laughed as well...but went on to explain to all the trainees what he was doing. He told them all about how they are like super heroes. They have the potential to "Save the Day" with their attitude and the way they handle themselves both on the job and off. He said, "People like Superman and my friend, Wonder Woman, try to be positive, upbeat and most importantly, they try to make a difference." He went on to tell them that is what would set them apart from the rest of the employees. He really made everyone in that room feel special and important about what they were doing. It was unreal. With all the other speakers the crowd appeared fairly bored, especially by the end of the day. Chad told me he thought it was his job as the last speaker to make them laugh and have fun after working hard all day. I remember telling him how proud I was of him. I told him that was why he had been promoted so quickly...because he not only did his job. He cared about his job and the people he worked with. I saw several people get up and as they were leaving they either hugged Chad or patted him on the back and told him he had done the best job and they wished the whole day had been like that!

I also would like to tell you about the first time I met Amanda, Cassidy's mother. I was trying to make small talk with her and asked her how her and Chad were doing...if she saw a future with him. At this time I thought she was 22 as that was what she had told Chad. She told me, "I have never been happier. Chad is the best thing that has ever happened to me." She added, "He is wonderful with my daughter. Treats her like his own he spoils her so bad." I told her that was Chad. He had always loved children.

It was true...Chad loves children. I remember when Chad came to tell me Tristan, his ex-wife, was pregnant. I got to work around 8am and Chad was waiting for me. I got in his car and he told me he had just found out that morning Tristan was pregnant. Chad went on to tell me doctors didn't think he would ever have children because of a surgery he had as a child. He was crying as he told me this was such a miracle.

When Tristan and Chad broke up, Chad was absolutely devastated. He would come see me with tears in his eyes on a regular basis. He wanted nothing more than to make things work between them not only because he loved Tristan but for the children as well. He didn't want them to grow up in a broken home. He missed them every day. He fought for primary physical custody of Kyle and visitation of his step son, Brent, and won. Chad was happy with that...but through it all he wanted to maintain a good relationship with Tristan. He loved her dearly and felt it was important for the children they remain close friends.

Chad wanted the children to have a good upbringing. It was very important to him they go to a good school. Chad and Tristan decided on Tri City Christian Academy. The boys enjoyed it there and they knew they would receive a good education along with good values. Once Amanda entered Chad's life he wanted the best for Cassidy too. There were a few occasions in which Chad didn't like some of the careless accidents Cassidy had when she was in Jeff Marshall's care. Chad told me he talked to Amanda one night and explained to her he didn't agree with it and he wanted Cassidy to go to a good day care where she would have a lot of attention. Chad told me he felt bad because Amanda got upset and told him it was her child and she couldn't afford day care so she would be fine with Jeff. Chad explained to Amanda he would be more than happy to pay for Cassidy's daycare so they began making a list of places. Chad called each and every one of them. I even suggested a few to Chad. I know Chad spoke with the principal of Tri City Christian Academy and asked if Cassidy could go to day care there because he was concerned about the carelessness in which Cassidy was being cared for. Chad told me he and Amanda were sad she couldn't go to the same school as Kyle. Because Cassidy wasn't quite 2 and/or potty trained she would have to wait a little longer to attend school there.

I hope I am not rambling on and on. I just feel it is so important to explain to you the kind and gentle person Chad was and still is Today. Chad is one of the most sensitive people I have ever met in my life. I feel it would be a terrible injustice to let a wonderful and innocent person pay for a crime he didn't commit. Chad has been punished long enough and so has his family. Kyle misses his father just as Chad misses Kyle. We already have one child separated from a parent, we shouldn't have another.

I spoke with Chad after the verdict...it broke my heart to hear him so distraught. I started to cry with him and he said, "Stephanie, I'm sorry...that's why I tried to keep it together during the verdict because I didn't want to make it more difficult for you all." What person would still be worried about his family and friends at a moment like that, Chad would. He always puts others feelings before his own.

I sat in your courtroom with all of Chad's family and friends. I remember people saying how they couldn't believe the outpouring of support for Chad. Many times, people face charges like that without even their mother supporting him. Well...I think the people, and the number of people their should speak volumes. Chad has made a difference not only in my life but the lives of so many. I feel it is not only important but necessary you know all this and more about Chad. A verdict must be made on substantial evidence. The only evidence in this case is that which was found at Jeff Marshall's home on his sheets and on the napkin he left on his dresser. It is the responsibility of the court to have justice prevail. I believe in that and I believe in you.

At this time I thought she was 22 as that was what she had told Chad. She told me, "I have never been happier. Chad is the best thing that has ever happened to me." She added, "He is wonderful with my daughter. Treats her like his own he spoils her so bad." I told her that was Chad. He had always loved children.

It was true...Chad loves children. I remember when Chad came to tell me Tristan, his ex-wife, was pregnant. I got to work around 8am and Chad was waiting for me. I got in his car and he told me he had just found out that morning Tristan was pregnant. Chad went on to tell me doctors didn't think he would ever have children because of a surgery he had as a child. He was crying as he told me this was such a miracle.

When Tristan and Chad broke up, Chad was absolutely devastated. He would come see me with tears in his eyes on a regular basis. He wanted nothing more than to make things work between them not only because he loved Tristan but for the children as well. He didn't want them to grow up in a broken home. He missed them every day. He fought for primary physical custody of Kyle and visitation of his step son, Brent, and won. Chad was happy with that...but through it all he wanted to maintain a good relationship with Tristan. He loved her dearly and felt it was important for the children they remain close friends.

Chad wanted the children to have a good upbringing. It was very important to him they go to a good school. Chad and Tristan decided on Tri City Christian Academy. The boys enjoyed it there and they knew they would receive a good education along with good values. Once Amanda entered Chad's life he wanted the best for Cassidy too. There were a few occasions in which Chad didn't like some of the careless accidents Cassidy had when she was in Jeff Marshall's care. Chad told me he talked to Amanda one night and explained to her he didn't agree with it and he wanted Cassidy to go to a good day care where she would have a lot of attention. Chad told me he felt bad because Amanda got upset and told him it was her child and she couldn't afford day care so she would be fine with Jeff. Chad explained to Amanda he would be more than happy to pay for Cassidy's daycare so they began making a list of places. Chad called each and every one of them. I even suggested a few to Chad. I know Chad spoke with the principal of Tri City Christian Academy and asked if Cassidy could go to day care there because he was concerned about the carelessness in which Cassidy was being cared for. Chad told me he and Amanda were sad she couldn't go to the same school as Kyle. Because Cassidy wasn't quite 2 and/or potty trained she would have to wait a little longer to attend school there.

I hope I am not rambling on and on. I just feel it is so important to explain to you the kind and gentle person Chad was and still is Today. Chad is one of the most sensitive people I have ever met in my life. I feel it would be a terrible injustice to let a wonderful and innocent person pay for a crime he didn't commit. Chad has been punished long enough and so has his family. Kyle misses his father just as Chad misses Kyle. We already have one child separated from a parent, we shouldn't have another.

I spoke with Chad after the verdict...it broke my heart to hear him so distraught. I started to cry with him and he said, "Stephanie, I'm sorry...that's why I tried to keep it together during the verdict because I didn't want to make it more difficult for you all." What person would still be worried about his family and friends at a moment like that, Chad would. He always puts others feelings before his own.

I sat in your courtroom with all of Chad's family and friends. I remember people saying how they couldn't believe the outpouring of support for Chad. Many times, people face charges like that without even their mother supporting him. Well...I think the people, and the number of people their should speak volumes. Chad has made a difference not only in my life but the lives of so many. I feel it is not only important but necessary you know all this and more about Chad. A verdict must be made on substantial evidence. The only evidence in this case is that which was found at Jeff Marshall's home on his sheets and on the napkin he left on his dresser. It is the responsibility of the court to have justice prevail. I believe in that and I believe in you.
