3. IF NO WORK WAS COMPLETED IN REFERENCE TO THE CASE ASK THEM FOR THAT IN WRITING THROUGH FAX OR MAIL. CALL 603-271-1417. EXPLAIN YOU CONTACTED THE OFFICE OF PUBLIC DEFENDER AND NO WORK WAS COMPLETED. THEY WILL CONTACT OFFICE AND THIS BILL WILL BE CLEARED.
4. ASK FOR COPIES OF EVERYTHING TO BE FAXED OR MAILED IN REFERENCE TO THIS BILL.
