Fire permits required for brush burning

ROCHESTER - It is that time of the year when the Rochester Fire Department is requiring anyone wishing to burn brush to obtain a written permit from the department.

Brush cannot be burned until after 5 p.m., and residents cannot burn any wood that is over five inches in diameter. Once a fire has been started, the person obtaining the permit must remain with the fire until it is out.

If you wish to burn brush, call the department to see if permits are going to be issued that day. If it is windy, permits may not be issued.
